AS THE PLANS FOR BUILDING THE CCA FOR USE AS A FACILITY BY THE ORGANIZATION AND THE FORMATION OF THE LLC IS NO LONGER PLANNED, THE ORGANIZATION DETERMINED THE PREVIOUSLY RECORDED ASSETS AND LIABILITIES WERE IMPAIRED AS OF JUNE 30, 2020. THE ORGANIZATION RECOGNIZED AN IMPAIRMENT OF \$6,410,763 IN THE ACCOMPANYING FINANCIAL STATEMENTS.
